### Services and fees

There is an initial registration fee of \$500.00 plus GST (\$550.00 GST inclusive), which includes the first year of membership of ALIA CIPS. The annual membership fee for subsequent years will be decided subject to a review of the service.

Service fees of up to 12% per subscription per year will apply. Services to be provided include: administration of subscriptions, invoicing, managing trials and evaluation of information products, disseminating usage statistics and arrangement of training.
